Parental Consent, Waiver and Release of Liability

This is to certify that I, as parent/ legal guardian with legal responsibilities for the minor participant identified below (the "Player"), execute this Parental Consent, Waiver and Release of Liability for and on behalf of the Player in consideration of the Player's participation in activities of or associated with The South Reno Babe Ruth League, Inc. ("SRBR"). I represent to SRBR that the Player has been found physically capable of participating such activities, and I hereby fully consent to the Player participating in events and other activities sponsored by or associated with SRBR.

I recognize the possibility of injury and illness, and I am aware that baseball is a vigorous team sport that at times involves severe cardiovascular stress and violent physical contact. I understand that baseball involves certain risks (including, but not limited to, death, serious neck and spinal injuries) resulting in complete or partial paralysis, brain damage and/or injury to bones, joints, muscles and internal organs. I acknowledge that equipment which may be provided by SRBR for the Player's protection may be inadequate to prevent serious injury. I further understand that baseball involves a particularly high risk of ankle and knee injury. In addition, I understand that participation in baseball in SRBR may involve activities incidental thereto; including, but not limited to, travel to and from site, off-site travel to other events and activities not affiliated with SRBR. Participation at these other events and activities may be at sites that are remote from available medical assistance and there may be possible reckless conduct from other participants.

With my consent, the Player is voluntarily participating in all SRBR and ancillary activities with full knowledge of the possible dangers involved, and I hereby agree to accept any and all inherent risks of property damage, personal injury or death of the Player. I agree for myself, the Player and his/her co-parent or co-guardian, and all other heirs, administrators, executors, successors, assigns and next of kin, to discharge, release, hold harmless and waive subrogation to SRBR and its agents, employees, sponsors, volunteers, owners, lessors of the premises and all others that are involved, from any and all damages or liabilities incident to the Player's involvement or participation in the activities, events or programs as provided above, even if arising from ordinary negligence, to the fullest extent permitted by

law. I agree not to sue any of the persons or entities listed above for any of the claims or liabilities that I have waived, released, or discharged herein.

I affirm that I have read and fully understand the foregoing, that I am freely signing this consent, waiver and release and that I am giving up my legal rights and/or remedies which may be available to me for the ordinary negligence of SRBR or any of the parties listed above. Further, I understand that this consent, waiver and release is intended to be as broad and inclusive as permitted by the laws of the State of Nevada and agree that if any portion hereof is held invalid, the remainder of this consent, waiver and release will continue in full force and effect.
